#### Introduction

The selection process for Construction Management (CM) at-Risk firms for the Facilities Work Program FY 05-06 (as may be amended from time to time) and which may include three additional years was completed in January 2006. CM at-Risk firms were solicited for Category "C" projects to provide pre-construction services for projects with construction values under \$5 million.

The final ranking for Category C is as follows:

#### **Background**

Aventura Engineering and Construction Corp. (Aventura) was commissioned by the Board on June 14, 2006 as the CM at-Risk to perform pre-construction services for Deferred Maintenance Package #24, General Repairs and Rehabilitation at Greynolds Park Elementary School and Greynolds Park Primary Learning Center (PLC), Project No. A01099, and Scott Lake Elementary School, Project No. A01141. Staff negotiated a GMP with Aventura and awarded the Greynolds Park Elementary School and PLC project at the June 2008 Board meeting. However, the CM notified staff that it was unable to obtain the bonding required for this project. A Notice of Default of Contract and Recommendation of Termination for Cause on both projects was issued to Aventura on August 12, 2008. The replacement of Aventura as the CM at-Risk firm is contingent upon Board approval of a companion Board item for termination for cause (F-30).

#### Assignment of Replacement CM at-Risk Firm

The Category "C" CM at-Risk firms are assigned projects based on the alignment of construction values with each firm's capabilities, pre-qualification certificate amounts, workload, performance and scheduling of each project. Based on these criteria, staff assigned BDI Construction Company (BDI) as the replacement CM at-Risk firm to the referenced projects.

Negotiations with BDI have been successfully completed as follows:

#### **Project Scope**

The scope of work for each project includes, but is not limited to, the following general repairs and rehabilitation:

# 1. Greynolds Park Elementary and Greynolds Park PLC, Project No. A01099

- Site Resurface the parking lot(s); replace existing fence, gate, flagpole and traffic signs; replace asphalt walkways and concrete sidewalks; remove exposed concrete footing near east stair; repair ramp apron and guardrails, new asphalt at PE Courts; replace backflow devices and downspouts and drain pans and connect to existing underground storm system;
- Building Envelope Replacement of aluminum windows, add joint sealant in several buildings; replacement of exterior steel doors, frames and hardware; add waterproofing; block-up existing ventilation at toilet rooms; provide ADA-complaint ramps to all buildings;
- Interior Major paint throughout; provide storage shelves, handrails, thresholds, and wood doors; new panic hardware in dining area and media center; replacement of existing display case glazing, stair treads and nosings; replacement of all markerboards, acoustical ceiling, VCT flooring and new cabinets in building 15; coordinate all work with M-DCPS office of Asbestos Abatement;

- Structural Replacement of expansion joint covers in several buildings and structural concrete in building 1;
- HVAC Replace existing air conditioning wall mounted units in all classrooms; and provide new wall mounted exhaust fans;
- Plumbing Renovate all group toilet rooms to meet ADA requirements; replace all existing water fountains to meet ADA requirements; and
- Electrical Up-grade all existing outlets near wet areas to comply with GFI requirements in primary classrooms; provide emergency lighting according to Safety-to-Life Report and exit signs with battery back-up; repair exposed wiring in electrical panels and provide covers; redistribute the electrical load for the existing A/C window units; replace all damaged convenience outlets and make minor repairs.

Based on Phase III 100% documents prepared by ADA Engineering, Inc., (dated May 25, 2007) the estimated cost of construction for this project is \$1,333,534.

# 2. Scott Lake Elementary, Project No. A01141

- Site Repaint paved play area; re-stripe parking areas; replace wheel stops; remove underground storage tank;
- Building Envelope provide new rescue emergency panels and new windows in building 7.
- Interior Remodel Bertha Abess Center (building 7) to provide new classrooms and related support spaces, replacement of all building systems; major paint throughout the facility; provide new signage; replacement of ceiling tiles and markerboards in classroom buildings 2, 3, 5, 6 and 8;
- HVAC Replace 15 ton evaporator condenser in Media Center and in building 7;
   replace existing wall-mounted air conditioning units in all classrooms;
- Plumbing replace boiler and unit ventilators; add new hot water heater and connect to city gas;
- Electrical Replace interior lighting and battery pack emergency lights; provide fire alarm system and lightning protection; provide additional receptacles in classroom buildings.

Based on Phase III 100% documents prepared by ADA Engineering, Inc., (dated July 23, 2007) the estimated cost of construction for this project is \$1,608,486.

### Terms and Conditions

The agreement negotiated by staff contains the following terms and conditions:

- 1. BDI agrees to provide the requisite pre-construction services for this project, including, but not limited to, the following:
  - Review all design and construction documents prepared by the Project Architect/Engineer, as well as all existing on-site conditions, to ensure constructability of the project.
  - Provide the District with value engineering analysis, cost saving recommendations and estimates throughout the various phases of design.
  - Prepare a master construction schedule to identify potential time saving measures and to facilitate the timely completion of the project.
  - Coordinate with District staff and Project Architect/Engineer to ensure that all the necessary testing, permitting applications and regulatory agency reviews are accomplished.
  - Identify all the various bid packages needed to successfully execute the project, and conduct pre-bid conferences with qualified sub-contractors, material suppliers and equipment vendors.
- 2. The negotiated combined lump sum fee for pre-construction services is \$31,500. This fee represents approximately 1.05% of \$2,980,940, the combined estimated construction cost as follows:

Greynolds Park Elementary & Greynolds Park PLC:

\$15,750

Scott Lake Elementary:

\$15,750

- 3. Costs for printing shall be reimbursed by the Board on a direct cost basis;
- 4. The agreement provides for termination by the Board prior to the GMP, with or without cause, upon written notice to the CM at-Risk firm; whereas the CM at-Risk firm may terminate the agreement, with special cause only, upon written notice to the Board in accordance with the terms of the Agreement;
- 5. The Board is under no obligation to assign a minimum number of projects or minimum value to the CM at-Risk firm under this agreement;
- 6. Upon completion of the pre-construction services, the CM at-Risk firm shall negotiate a Guaranteed Maximum Price (GMP) for the construction project. If accepted, staff will submit the negotiated GMP for Board approval; and
- 7. BDI Construction Company has agreed to the terms and conditions of the contract and will commence services upon Board commissioning.
