In order to maintain a water line easement constructed to provide adequate fire protection and water services to the South Miami K-8 Center school site, Miami-Dade County has requested that a 12-foot wide water line easement be granted by the district.

The 12-foot wide water line easement described will cover the area of the water line installations at the 9-acre school site. This area is legally described in Exhibit "A", attached hereto.

The Grant of Easement will be reviewed and approved by the School Board's Attomeys Office prior to execution. In addition, the proposed easement has been reviewed and recommended by the Office of School Facilities. Public utility facilities constructed on Board-owned property will be conveyed, with appropriate easements, to Miami-Dade County for future maintenance and operations.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, authorize the execution of the water line easement at the South Miami K-8 Center school site, Project No. A01107, in favor of Miami-Dade County.


