The purpose of this bid is to purchase, at firm unit prices, quantities, as may be required, to furnish and install, carpet and floor tile, in schools and facilities, for Maintenance Operations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Nine (9) vendors responded to this advertised solicitation.

The newly revised District's Master Specifications Guidelines do not recommend the use of rubber tiles with raised studs, for sanitary reasons, therefore, it is recommended that Group 12, Items 38 through 47 be rejected. Competitive prices will be solicited for these items using revised specifications, pursuant to Board Rule 6Gx13- 3C-1.111 - - Bidding Process - - Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
