Miami Gardens Elementary enriches its "community of learners" by conveying an atmosphere of high academic standards, respect for cultural diversity and individual differences. The school has established and maintained many "family traditions" within the community that have resulted in shared trust and ownership among stakeholders. Within the past two years, four teachers have sought advanced degrees and three teachers have received National Board Certification.

In February and March, the Florida Comprehensive Assessment Test (FCAT) was administered to students in grades 3-11 as part of the state's overall plan to increase student achievement. The FCAT consists of criterion-referenced tests measuring selected benchmarks in the areas of mathematics, reading, science, and writing and norm-referenced tests measuring individual student performance against national norms in the areas of reading and mathematics.

Miami Gardens Elementary School students performed exceptionally well on the FCAT. The hard work and dedication of the school's students, parents, teachers, and administrators resulted in gains on the FCAT and an increase in the school's performance grade from an "F" to a "B."
