At its meeting of July 11, 2007 (Item F-31), the Board commissioned Stobs Brothers Construction Company for "Deferred Maintenance Package #12, Renovations, Maintenance and Repairs" at D.A. Dorsey Educational Center, Project No. A01122. This contract provides for construction services to the Board and a Guaranteed Maximum Price (GMP) for construction.

The GMP for Deferred Maintenance Package #12, Renovations, Maintenance and Repairs" at D.A. Dorsey Educational Center, by the Construction Manager, Stobs Brothers Construction Company is \$2,569,588 (contingency included \$233,599). The Project Architect's estimate is \$2,527,280 and the independent cost estimate is \$2,593,595 This GMP covers all required work and includes subcontracts, materials, contingency, general conditions, bond, and overhead and profit.

The scope of work for this project includes, but is not limited to, the following:

- Interior work includes electrical system upgrades, interior lighting replacement, replacement of acoustical ceilings, replacement of carpet and acoustical panels at the auditorium, and replacement of boiler.
- ADA upgrades include providing thresholds, ramps, and door hardware at
 educational spaces and administrative areas, renovation of various group toilet
 rooms, new handicapped toilet rooms for students and staff, new handrails at
 main entrance, and new compliant ramp on the north side of the school.

Site work to include new security enclosure fence/gate at open courtyards, removal of underground storage tank, and new bollards to block vehicular traffic.

This project is scheduled for substantial completion on November 25, 2009 which is 350 calendar days from Board approval date
