The G0 Salary Schedule sets the compensation rates for temporary and part-time hourly community and after-school care employees.

The minimum wage for the State of Florida is increasing from \$6.79 to \$7.21 per hour effective January 1, 2009. The pay rates established for several of the positions on the G0 salary schedule will be below the new minimum wage. As a result of the new minimum wage increase, selected positions in Pay Grades 1 and 2 are recommended for a rate increase to \$7.21 per hour effective December 26, 2008, which is the beginning of the pay period immediately preceding January 1, 2009.

The proposed 2008-2009 G0 Salary Schedule for temporary and part-time hourly community and after-school care positions is attached for approval.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, approve the amended G0 Salary Schedule and adjust the corresponding

salaries, effective December 26, 2008.
