Background

The Miami-Dade County Metropolitan Planning Organization (MPO) has partnered with the School District to promote pedestrian and vehicle driver safety at the senior high school level. To advance this safety initiative in a meaningful way, the MPO facilitated a \$25,000 grant to develop a Senior High School Student Safety Campaign. The Campaign is to include a Public Service Announcement (PSA) and poster contest component. The \$25,000 grant funding will be used for the purchase of safety promotional items, and for the reproduction of the winning PSA's and posters, which will be distributed to all District senior high school campuses during the annual National Teen Driver Safety Week, designated by the U.S. Congress in the third week in October.

Senior High School Student Safety Campaign

With the assistance of the Public School Community Traffic Safety Team (Public Schools CTST), in January 2009, the School District organized the Senior High School Student Safety PSA and poster contest among all interested M-DCPS Senior High School students. In keeping with the theme of the safety campaign, the contest focused on encouraging applicants to promote pedestrian and vehicular safety via a 30-second PSA or poster geared to inspire an audience of their peers.

In an effort to maximize student participation, District staff secured funding to provide monetary awards for three winners in each category, totaling \$950. The contributing entities were: the South Florida Educational Federal Credit Union, which donated \$450, and State Farm Insurance Company, through its Good Neighbor Citizenship Program, which donated \$500.

Contest Winners

The Public Schools CTST judged the entries, and selected six winners; three winners per production category. The submittals were scored for creativity, effectiveness and motivational appeal to inspire senior high school-aged students.

A total of twenty-eight students participated in the safety campaign from the following schools.
