OPERATIONS

The purpose of this bid is to purchase and deliver, at firm unit prices, quantities, as may be required, of cafeteria supplies, for the Department of Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Eight (8) vendors responded to this advertised solicitation. This is an award to a primary and alternate vendor.

Items 5 through 10, 14, 15, 18, and 20 through 23 were awarded to a primary vendor and Items 5 through 10, 14, 18, 21, and 22 were awarded to an alternate vendor by the Board, on October 15, 2008, for an estimated expenditure amount of \$1,234,332.

The October 15, 2008, Board Agenda Item E-143, incorrectly reflected the description of Item 18 as Wrap, plastic, 18" roll, instead of Wrap, plastic, 12" roll.

An alternate for Item 13 will not be awarded, inasmuch as the price is considered excessive.

Identical prices were submitted on Item 17 – Wrap, plastic, 18" roll, by A.G.E. Paper Company, of Hialeah, Florida, and Lace Foodservice Corporation, of Miami, Florida. The recommendation reflects the award of this tie low bid item to Lace Foodservice Corporation, the Miami-Dade County M/WBE vendor, pursuant to Board Rule 6Gx13-3C-1.061 - Identical Prices - Priorities for Award.

This award also recommends that Item 19 – pan liners, be rejected due to ambiguous specifications. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6GX13- 3C1.111 Bidding Process - Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
