The District recently completed construction of Dr. Manuel C. Barreiro Elementary School (School), located at 5125 SW 162 Avenue, and the facility opened for the 2008-09 school year. As part of the project, Miami-Dade County (County) has requested that the District dedicate a portion of the Board-owned site for use as public right-of-way.

The area to be dedicated totals approximately 36,612 square feet, or .84 acres, more or less, and is more fully described in Exhibit "A", attached hereto.


The right-of-way document will be reviewed by the School Board Attorney's Office and the Office of Risk and Benefits Management prior to execution. The School Principal, South Central Regional Center Superintendent, and the Office of School Facilities all recommend the proposed right-of-way dedication.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Chair and Secretary to execute the necessary documents to dedicate land to Miami-Dade County for right-of-way purposes, adjacent to Dr. Manuel C. Barreiro Elementary School, located at


