The IO Salary Schedule consists of part-time, temporary and designated full-time positions that are not aligned to any bargaining unit or employee group.

The partnership between Miami-Dade County Public Schools and the Summer Employment Program through South Florida Workforce Investment Board required the establishment of two positions. The Student Summer Intern position and the Summer Intern position are for students working this summer as a result of the American Recovery and Reinvestment Act.

On October 15, 2008, the School Board approved Agenda Item H-2, Job Descriptions for the Office of the Inspector General. This Board item stated these positions are non union contract. Therefore, the following positions are being deleted from the IO Salary Schedule: OIG Special Agent, OIG Assistant Legal Counsel, OIG Auditor, OIG Administrative Assistant, OIG Contract Oversight Specialist and OIG Investigative Analyst.

The Federal minimum wage is increasing from \$6.55 to \$7.25 per hour effective July 24, 2009. On this date, Florida employers must increase the minimum wage from \$7.21 to \$7.25. All pay rates on the 10 Salary Schedule are in compliance with the new minimum wage with the exception of the Work Study Enrollee and the Student Food Service Worker positions. In order to bring the Work Study Enrollee and the Student Food Service Worker positions to the new minimum wage, it is recommended that these positions be granted a rate adjustment to \$7.25 per hour effective July 24, 2009.

The proposed 2009-2010 I0 Salary Schedule for part-time, temporary and designated full-time positions is attached for approval.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, approve
