Since its inception in 1976, the Dial-A-Teacher program has consistently served the students of Miami-Dade County Public Schools by providing a free, live home learning support in the core areas of Math, Language Arts/Reading, Science and Social Studies as well as in various languages.

Originally serving the community with only one telephone center located in Ponce de Leon Middle School, today the program has expanded to service over 650 calls each month, totaling an estimated 1,000,000 students since its inception, ensuring that the questions and concerns of all parents are students are addressed each day.

The DAT program runs from September to May of each school year and after school hours from 5:00pm-8:00pm on Mondays through Thursdays of each week. The accomplished goal has always been to ensure that each student is given the opportunity to receive the necessary assistance that can help make a difference in their education.

From 1982-1995, the DIAL-A-TEACHER Television Program went live on Cable TAP, then on WLRN-TV with the help of Mr. Don McCullough, Station Manager and Mr. Martin Yoffee, Cable TAP Director. Teachers provided lessons in the core subject areas and students had direct participation with the teacher and lesson by calling in from home.

The Dial-A-Teacher program produced live television shows from the Youth Fair and participated in community parade floats in the Junior Orange Bowl and Martin Luther King Day Parades.

The Dial-A-Teacher Program has been recognized nationally, at the state level, and locally as an exemplary program.
