Request For Proposals No. 055-JJ10 – PSYCHIATRIC-CONSULTATION SERVICES FOR UP TO 51 PROGRAMS WITH SELF-CONTAINED CLASSES FOR STUDENTS WITH EMOTIONAL/BEHAVIORAL DISABILITIES, is to provide on-site psychiatric consultation to assist in the diagnosis and programming of students assigned to self-contained classes for students with emotional/behavioral disabilities, for the Division of Special Education (SPED). This is a term proposal. Three (3) proposers responded to this advertised solicitation.

The Division of Special Education contracts with outside psychiatrists to provide on-site services for up to 51 identified programs for full-time students assigned to self-contained classes for students with emotional/behavioral disabilities. Each site will receive approximately three to four hours of on-site services every five weeks during each school year, depending on students' needs. On-site services will include direct interview/evaluation of students, consultation with parents and/or staff, case management, and professional-development activities for clinical staff, including the provision of continuing education units.

The Evaluation Committee met to evaluate proposals received in response to the Request For Proposals, on April 21, 2009. Three proposals were presented for consideration: Community Health of South Florida, Inc.; Institute for Child and Family Health; and The Bertha Abess Children's Center, Inc. After considerable deliberation, the committee recommended the three proposals for award.

Upon further negotiations by Procurement Management, Institute for Child and Family Health and Community Health of South Florida, Inc. have agreed to reduce their fee from \$150 per hour to \$145 per hour, providing a cost savings to the District of \$4,940 per year.
