**STRATEGIC PLAN: IMPROVE AND EXPAND STUDENT SERVICES**

Request For Proposals No. 057-JJ10 – SPEECH AND LANGUAGE PATHOLOGY SERVICES, is to provide speech and language pathology services, needed as related support services, for the Office of Special Education, Alternative Outreach and Psychological Services. This is a term proposal. Twenty (20) proposers responded to this advertised solicitation.

Services may include articulation therapy, language therapy, and voice therapy, in addition to screenings and diagnostics. Students may be in regular programs or in ESE programs (e.g., autistic, learning disabled, physically impaired, educable or trainable mentally handicapped).

A meeting of the Evaluation Committee to review the proposals was held on April 27, 2009. Twenty (20) proposals were presented for consideration: ABC Speech and Language Therapy, Inc.; All Source Recruiting Group, d.b.a. Arador Health Solutions; Audrey B. Greenwald, MS, CCC-PA; Cambridge Healthcare; Cobb Pediatric Speech Services, Inc., d.b.a. Cobb Pediatric Therapy Services; Community Rehab Associates, Inc.; CompHealth Medical Staffing; Cross Country Staffing;

Dependable Therapy, Inc.; EBS (Educational Based Services); Hearing & Speech Center of Florida, Inc.; Interactive Communication LLC; Invo Healthcare Associates, Inc.; Kaleidoscope Family Solutions, Inc.; MDI Medical, LLC; Mediscan Staffing Services; Progressus Therapy, Inc.; Speech Pathology and Educational Center, Inc.; Sunbelt Staffing Solutions, Inc.; and Supplemental Health Care. After considerable discussion, the Committee recommended that six (6) proposers be recommended for award.

The speech and language pathology service agencies that are listed in this item with out-of-state addresses are national agencies that provide staff for a number of health-related fields in different states. These agencies will contract with independent pathologists, who are licensed in the State of Florida, to provide these services, upon request. There is a critical shortage of speech pathologists; however, every attempt will be made to utilize the agencies offering the lowest hourly rates, to the extent possible, based upon the availability of pathologists.
