SUBJECT: AUTHORIZATION TO EXERCISE THE THIRD-YEAR OPTION OF THE FOUR-YEAR AGREEMENT WITH ENHEALTH ENVIRONMENTAL, INC., TO PROVIDE ENVIRONMENTAL CONSULTING AND TESTING SERVICES AS AN ALTERNATE / QUALITY CONTROL CONSULTANT

On July 11, 2007, the Board commissioned Enhealth Environmental, Inc. (EEI), to provide Environmental Consulting and Testing Services (EC&TS) as an Alternate/Quality Control Consultant for a four-year term. The Agreement provides for a four-year term from July 11, 2007 through July 10, 2011, with the second, third and fourth years at the Board's option, under the same terms and conditions.

The total paid to date for the second term under the Agreement was \$2,500 for EEI. The most recent overall performance evaluation score issued by staff to the firm was for the period ending May 18, 2009. Based on a performance scale of 1-5, EEI received 2.75.

Based on the above information, staff recommends authorization to exercise the third-year option of the Agreement with EEI as an EC&TS Alternate/quality Control Consultant under the same terms and conditions.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent, or his designee, to exercise the third-year option with Enhealth Environmental, Inc., to provide Environmental Consulting and Testing Services as an Alternate / Quality Control Consultant under the same terms and conditions.
