REQUEST AUTHORIZATION TO ACCEPT TWO GRANT AWARDS FROM THE FLORIDA DEPARTMENT OF EDUCATION (FLDOE) FOR FUNDING UNDER THE CARL D. PERKINS CAREER AND TECHNICAL EDUCATION IMPROVEMENT ACT OF 2006, THE CARL D. PERKINS CAREER AND TECHNICAL EDUCATION, SECONDARY AND POST SECONDARY PROGRAMS, SECTIONS 131 AND 132; AND TO ENTER INTO A CAREER PATHWAYS CONSORTIUM WITH MIAMI DADE COLLEGE

Authorization is requested to accept two grant awards from the Florida Department of Education (FLDOE), in the approximate amounts of \$4,414,487 and \$1,382,747 totaling \$5,797,234, for funding under the Carl D. Perkins Secondary and Post Secondary Career and Technical Education, Sections 131 and 132, grants for the grant period of July 1, 2009 through June 30, 2010. The Secondary and Post Secondary grants will be managed by the Division of Career and Technical Education. The grant programs address the District's goals of ensuring achievement of high academic standards by all students and developing students so that they are able to successfully compete in the global economy.

Under the Carl D. Perkins Career and Technical Education Improvement Act of 2006, the FLDOE authorized funding through a grant application process for Florida school districts to develop more fully the academic, career, and technical skills of secondary and post secondary students who elect to enroll in career and technical education programs and to promote a seamless transition between secondary and post secondary education.

To implement the state's program of study requirement, the body of work initiated by the 2008-2009 Miami-Dade Career Pathways Consortium, composed of partners from M-DCPS Division of Career and Technical Education and Miami Dade College, will be continued and funded through Carl D. Perkins Secondary, Post Secondary, and Miami Dade College's basic grant allocations as shown below:

The District will serve as fiscal agent for the Miami-Dade Career Pathways Consortium.

The Secondary and Post Secondary grant applications contain supportive data and funding proposals for implementing and improving career and technical education services and programs throughout the District. These programs of study are designed to provide students with the necessary training to meet present and emerging workforce needs, preparing them for job opportunities in Miami-Dade County, the state, and the nation. In addition, these programs serve students at the secondary and post secondary levels and will include disadvantaged, disabled, and limited English proficient students. Through the Miami-Dade Career Pathways Consortium, programs of study linked to workforce needs will be streamlined and enhanced through collaboration with secondary, post secondary, regional workforce and industry partners.

The 2008-09 total allocations for secondary and post secondary was \$6,400,766 and the total allocation for 2009-10 is \$5,797,234, a 8% decrease. No matching funds are required as a condition to receive the grant awards. In addition to a required 1.5% match from funding partners, the 2008-2009 Career Pathways Consortium received a state allocation in the amount of \$284,767; however, effective July 1, 2009, separate Career Pathways Consortia funding is no longer available through state reserves. Grant funds will be used for full-time and part-time personnel, curriculum development, supplemental classroom supplies, furniture, equipment, software, stipends, substitute teachers, professional development, contracted services, marketing and recruitment for career and technical education programs, and travel.

Official notification of these grant awards is expected on or before August 1, 2009. Reimbursement of grant-related expenditures is authorized effective July 1, 2009.

### RECOMMENDED:

That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- 1. accept two grant awards from the Florida Department of Education (FLDOE) for funding under the Carl D. Perkins Career and Technical Education Improvement Act of 2006, the Carl D. Perkins Career and Technical Education Secondary and Post secondary Programs, Sections 131 and 132, in the total amount of \$5,797,234, for the grant period of July 1, 2009 through June 30, 2010;
- 2. enter into a contractual agreement with Miami Dade College to accept funds as the fiscal agent of the Career Pathways Consortium in the approximate amount of \$58,977;
- 3. retain funds from the grant in an amount not to exceed the annually negotiated indirect cost rate, as allowed and approved by the FLDOE;
- 4. extend these programs and the contractual agreement as authorized through official notification from the granting agency in order to complete the goals of the program;
- 5. direct Financial Services to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board; and
- 6. authorize travel out-of-state as required by the grant parameters.
