On May 9, 2009, the American Civil Liberties Foundation of Florida announced the winners of the second annual Zelda Glazer Civil Liberties Writing Competition. Among those honored was senior Fabiana Ferrer, student in Ms. Martha Cabrera's class at Miami Springs Senior High School. Fabiana was recognized alongside fellow winners Noel Kassewitz and Bernadette Guerra, also seniors in Miami-Dade County Public Schools. The students all received scholarships ranging from \$500 to \$1,500 courtesy of the Zelda Glazer Scholarship Fund.

Established in 2007, the Zelda Glazer Scholarship Fund honors the memory and lifelong work of an amazing woman who for more than 40 years worked as a beloved Miami-Dade County Public Schools Language Arts teacher and administrator. Glazer was a dedicated advocate for civil liberties in our schools and community, and she worked hard to uphold our constitutional rights, especially for students in the areas of speech and journalism.

The ACLU of Florida's writing competition is an opportunity to recognize civil liberties scholarship that enhances an understanding of the principles of the U.S. Constitution. Winning essays were chosen based on the student's passion, content, writing proficiency, originality, focus and organization.

WHEREAS, Fabiana is deserving of recognition for her scholarly achievement and interest in pursuing important social issues;
