The following "Superintendent Authorized Requisitions" (SAR) had a purchase order issued within the guidelines of Board Rule 6Gx13- 3C-1.10 – Purchase Approval, which states that emergency purchases made in accordance with Board Rule 6Gx13- 3C-1.16 – Emergency Purchases, and approved by the Superintendent or his designee, will be reported to the Board as soon as possible.

This emergency request was required to continue services for the delivery and installation of furniture, fixtures and equipment, which was considered essential. Failure to provide these services would have severely impacted the educational needs of students. The bid award for these services was pulled at the September 10, 2008, Board meeting, due to a bid protest, which necessitated this emergency action. At the May 20, 2009, meeting, the Board entered a Final Order accepting the Administrative Law Judge's Recommended Order to dismiss the Petition of Protest and awarded Bid No. 062-HH10 – Relocation of Furniture, Fixtures and Equipment. This item reports the balance of purchases for services performed under the emergency purchase request.
