More than half of Miami-Dade County Public Schools students receive free or reduced price lunch.

Traditionally, food drives take place at specific times of the year during holiday observances. Two years ago, Herbert A. Ammons Middle School student Victoria Kontzamanys decided to start Spreading the Love during the week of Valentine's Day. The food drive collected 700 canned goods in its first year and has grown dramatically by collecting 1,000 cans this year. The seventh-grade student is passionate about feeding the hungry in her community and encourages other students to become involved

Research indicates that children who eat a nutritious breakfast are more likely to be alert and score higher on school tests. Miami-Dade County Public Schools supports programs that benefit the health and well-being of students and contribute to their academic success.
