The purpose of this bid is to purchase, at a firm unit price, quantities, as may be required, of environmentally friendly, hydrogen peroxide-based cleaner/degreaser, for Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Fifteen (15) vendors responded to this advertised solicitation. This is an award to a primary and an alternate vendor.

This is an environmentally friendly product, approved by the Florida School Plant Management Association, that will replace five different cleaning products currently used in Miami-Dade County Public Schools. When compared to a similar product used in Broward County Public Schools, the District's pricing was found to be 1.5% lower.
