On February 24, 2010, Governor Charlie Crist commemorated Black History Month with countless community leaders, educators and students from across Florida. The Governor held a reception celebrating the contributions of African-Americans, and stated that "the role the African-American community plays in our state is truly appreciated not only during Black History Month, but also throughout the entire year."

During the ceremony, the Governor honored three outstanding African-American educators with the 2010 Black History Month 'Excellence in Education' Award for their contributions to education. The recipients were nominated by their students and peers. Each received an award check for \$1,500 in addition to a \$200 gift card from the Office Depot Foundation.

Miami Springs Senior High School (MSSHS) teacher, and coach, Delmar Wilson was one of the outstanding educators recognized by the Governor with this prestigious award. Mr. Wilson is an exemplary educator and a dedicated member of the Miami Springs High School staff, going above and beyond the call of duty each day for the benefit of his students. He is also the head coach for the outstanding MSSHS boys' volleyball team, and an avid supporter of the school's athletic programs. A dedicated educator, Mr. Delmar Wilson is highly deserving of the Governor's prestigious recognition.
