The K-9 Unit undergoes extensive training throughout the year and has demonstrated expertise in conducting area canvases and building searches for narcotics and explosives. Since its inception, the K-9 Unit has conducted hundreds or educational presentations at our schools with the goal of promoting a positive, healthy relationship with the Miami-Dade's public school students.

Sergeant Reinaldo Perez has been a part of the M-DSPD for 22 years and has supervised the K-9 Unit for the past 15 years. He previously worked as a detective with the General Investigative Unit. His canine partner is "Combat," a six-and-a-half-year old German Shepherd specializing in explosives detection. Officer Imtyaz Dad has worked with the M-DSPD for 14 years and has been a K-9 officer for the past nine years. Before his assignment as a K-9 handler, he worked as a School Resource Officer. Officer Dad's canine partner is "Balto," a six-year old German Shepherd specializing in explosives detection.

Officer Angel Rodriguez has been with the M-DSPD for nine years and he has worked with the K-9 Unit for the past six years. He previously worked as a School Resource Officer. Officer Rodriguez's canine partner is "Liam," a six-year old Dutch Shepherd specializing in narcotics detection and criminal apprehension. Officer Victor Hernandez has worked with the M-DSPD for 14 years and has been a K-9 handler for the past seven years. Prior to his current assignment, Officer Hernandez worked as a detective with the General Investigative Unit. His canine partner is "Jago," a nine-year old Belgian Malanois specializing in narcotics detection and criminal apprehension.
