Inaugurated by the Academy of American Poets in 1996, National Poetry Month is now held every April, when publishers, booksellers, literary organizations, libraries, schools and poets around the country work together to celebrate poetry and its vital place in American culture. Thousands of businesses and non-profit organizations participate through readings, festivals, book displays, workshops, and other events.

During the entire month of April, *O, Miami Poetry Festival*, produced by the University of Wynwood and funded by the John S. and James L. Knight Foundation, is presenting a long series of events and traditional readings mixed with innovative poetry-in-public-places projects. The goal of the festival is for every person in Miami-Dade County to experience a poem. Events are conducted in multiple languages, sometimes simultaneously, often in collaboration with other cultural organizations. *O, Miami* culminates in a four-day series of readings from April 27-30, 2011 at the New World Symphony Hall in Miami Beach.
