Ramon Dominguez: suspension from his position as Custodian, at Westland Hialeah Senior High School for seven (7) calendar days, effective at the close of the workday on July 13, 2011, for just cause, including, but not limited to: violation of School Board Rules 6Gx13- 1.08, Violence in the Workplace; 6Gx13- 4A-1.21, Responsibilities and Duties; and 6Gx13- 4A-1.213, Code of Ethics. This action is taken in accordance with Sections 1001.32(2), 1012.22(1)(f), and 447.209, Florida Statutes and Articles II and XI of the Contract between the Miami-Dade County Public Schools and the American Federation of State, County, and Municipal Employees.

Alexander Bell: suspension from his position as School Security Monitor, at Miami Senior High School for ten (10) workdays, effective August 18, 2011, for just cause, including, but not limited to: violation of School Board Rules 6Gx13- 4A-1.21, Responsibilities and Duties; and 6Gx13- 4A-1.213, Code of Ethics. This action is taken in accordance with Sections 1001.32(2), 1012.22(1)(f), and 447.209, Florida Statutes.

Marlene D. Desdunes: suspension from her position as Teacher, at Biscayne Elementary School for ten (10) workdays, effective August 18, 2011, for just cause, including, but not limited to: misconduct in office; and violation of School Board Rules 6Gx13- 4A-1.21, Responsibilities and Duties; and 6Gx13- 4A-1.213, Code of Ethics. This action is taken in accordance with Sections 1001.32(2), 1012.22(1)(f), 1012.33, and 447.209, Florida Statutes; and State Board Rules 6B-1.001, 6B-1.006, and 6B-4.009, FAC.
