The purpose was to connect advocates across the nation who were working to end violence against women and children. In October 1987, the first Domestic Violence Awareness Month was observed. In 1989, the U.S. Congress passed Public Law 101-112 designating October of that year as National Domestic Violence Awareness Month.

An act of domestic violence occurs every 12 seconds in the United States. Domestic violence has no regard for socio-economic status, race, ethnicity, religion, employment status, physical ableness, age, education, marital status, or sexual orientation. Children who merely witness domestic violence suffer severe negative consequences. Domestic violence remains a devastating public health concern that demands significant consideration.

In 1995, the National Resource Center on Domestic Violence convened several national domestic violence organizations to launch a new initiative to support awareness of domestic violence programs and education efforts for Domestic Violence Awareness Month, which became known as the Domestic Violence Awareness Project (DVAP). The DVAP collaborates to collect, develop and distribute resources and relevant concepts to ongoing public and prevention awareness and education efforts throughout the year. In doing so, DVAP supports the rights of all individuals, especially women and children, to live in peace and dignity.
