The financial statements of Magnet Educational Choice Association (MECA), were audited by Sharpton Brunson & Company, P.A. MECA is a not-for-profit corporation organized and operated as a Miami-Dade County School Board's direct-support organization. The audit is required by State Board of Education Rule 6A-1.0013. The auditors concluded that the financial statements present fairly in all materials respects the financial position of MECA. No audit findings were reported. Total revenues for MECA were \$396,881. Total net assets at year-end were \$558,426.

The School Board Audit Committee reviewed this report at its December 7, 2010 meeting and recommended transmitting it to the School Board.
