A member of Alpha Phi Alpha Fraternity, Inc., Mr. Crapp has been recognized by numerous community organizations, including the African American Council of Christian Clergy, P.U.L.S.E., and Miami Dade College. As a result of his leadership and exceptional work as a city administrator, Mr. Crapp is featured in the April 2011 edition of the regional publication, *Legacy Magazine* and the national monthly magazine, *Black Enterprise*.
