FRAMEWORK: IMPROVE AND EXPAND CURRENT CURRICULUM

At the meeting held on March 9, 2011, The School Board of Miami-Dade County Florida, announced its intention to amend School Board Rule 6Gx13- 6A-1.331, Procedures for Providing Special Education for Exceptional Students and the Exceptional Student Education Policies and Procedures (SP&P) Effective Dates: 2009-2010 through 2011-2012 document incorporated therein by reference and made part of the rule. The document was previously approved by the School Board at its meeting held on November 17, 2009. The SP&P serves as the basis for identification, evaluation, eligibility determination and placement of students in special education programs. The document is also a component of the District's application for supplemental student funds available through the Individuals with Disabilities Education Act (IDEA).

In accordance with the requirements set forth in Rule 6A-6.03411, Florida Administrative Code (F.A.C.), the SP&P must be submitted every three years to the Florida Department of Education (FDOE) as a prerequisite for the use of weighted cost factors under the Florida Education Finance Program (FEFP). Although Board review and approval of the SP&P is required by law every three years, the document must be amended and submitted to the FDOE prior to the expiration of the current three-year cycle in light of new requirements set forth in Florida Statutes section 1003.573, that became effective on July 1, 2010, and revisions to select State Board of Education Rules promulgated during 2009-2010. In particular, substantive changes to the SP&P involve reporting, data collection, and monitoring the use of seclusion and restraint; exceptional student education eligibility; development of individual educational plans (IEPs); and participation in state and district assessments. The core content of the SP&P reflects the federal and state policies and procedures related to exceptional student education that apply to all districts.

The time to request a hearing or protest the adoption of this rule has elapsed.

In accordance with the provision of the Administrative Procedure Act, this amended rule is presented to The School Board of Miami-Dade County, Florida for adoption and authorization to file the rule in the official records of The School Board of Miami-Dade County, Florida.

The amended SP&P document includes reporting, data collection, and monitoring the use of seclusion and restraint; exceptional student education eligibility for specific programs; development of individual educational plans (IEPs); and participation in state and district assessments. Rule 6A-6.03411, Florida Administrative Code (FAC.), requires the approval of this document by FDOE as a prerequisite for the district's use of weighted cost factors under the Florida Education Finance Program (FEFP).

PROCEDURES FOR PROVIDING SPECIAL EDUCATION FOR EXCEPTIONAL STUDENTS

As a primary goal, it is the policy of The School Board of Miami-Dade County, Florida, to provide access for exceptional students to specialized instruction and related services that are individually designed to provide educational benefit to children with disabilities. An exceptional student shall be defined as any student who, because of physical, mental, emotional, or learning disability, is unable to receive an appropriate educational program without specialized instruction and, if appropriate, related services. This instruction may be provided in a regular class, a special class, or in a special facility. The term exceptional student shall also be applied to those students identified as gifted.

The Board will provide special educational programs to students who show eligibility and require special education in one or more of the following areas: autism spectrum disorder, deaf or hard-of-hearing, developmental delay, dual sensory impairments, emotional/behavioral disabilities, established conditions, homebound or hospitalized, intellectual disabilities, physically impaired with orthopedic impairment, physically impaired with traumatic brain injury, specific learning disabilities, speech and language impairments, and visual impairment. Services are also provided for the gifted student.

Exceptional Student Education is an integral part of Miami-Dade County Public Schools. Regular schools, special centers, special services, related state and local agencies, and resources are all utilized. All of the facilities and services of the regular school are made available to the exceptional student.

The document entitled *Exceptional Student Education Policies and Procedures (SP&P) Effective Dates: 2009-2010 through 2011-2012* is a part of and incorporated into this rule and will be submitted to the FDOE.
