As CEO and President of the Helen B. Bentley Family Health Center, Dr. Caleb A. Davis oversees all aspects of the federally-funded primary health care center. Under his leadership, the center offers pharmacy, lab, x-ray, dental, optometry, podiatry, pediatrics, obstetrics/gynecology, general medicine and mental health services. Dr. Davis is responsible for the quality of health care delivery, an \$8 million budget, a staff of 93 professionals, strategic planning as well as grants and other development proposals.

A long-time health advocate, Dr. Davis has served as the chairperson for the Florida Association of Primary Health Care Centers, Health Choice Network Health Services Management Network and the Dade County Primary Health Care Consortium. He is active in the National Association of Black Social Workers, National Association of Black Hospital Administrators, the Urban League, the Association of Mental Health Administrators and the Congress of Racial Equality.
