The purpose of this resolution is to make budget amendments to the Other Federal Programs Fund budget which are required to fully comply with grant terms and/or good accounting practices.

This resolution amends budgeted revenues and appropriations in the Education Jobs Fund by a decrease of \$(380,380). This decrease represents the value of individual grant awards reviewed and approved by the School Board from January 10 through March 25, 2011. Grants approved after this date will be included in the final budget resolution for Education Job Fund on September 7, 2011.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

1. adopt Resolution No. 2 FY2010-11 Special Revenue – Education Jobs Fund Spring Budget Review, decrease revenues and appropriations by \$(380,380); and
2. adopt the Summary of Revenues and Appropriations (page 2) and the Summary of Appropriations by Function (page 4).
