Today, Ms. Berry is one of the most influential Haitian American personalities in South Florida. She is the founder of Youth Talk Show, giving a radio voice to Caribbean youth. As host and producer of the Koze Fanm (Women's Issues) and Vwa Djaspora (Diaspora's Voice) radio shows, and Bonjou Miami television program, she brings awareness to the issues of Haitian women. She also focuses on educational, economic, medical, legal, political and social issues affecting the Haitian community at large through these outlets.

Ms. Berry is an excellent communicator and a gifted educator. Her most recent creative projects are in the fields of broadcasting and human development. She recently developed a new radio program titled, *Haitian America Voice* – a novelty in the Haitian-American community designed for youths and parents of all cultures and national origins.

Her passion for community development led her to establish the non-profit organization Positive Impact Foundation, Inc. The goal of Positive Impact Foundation is to empower youths and families by providing important information regarding community resources and staging events that build family bonds. As the Executive Director of the organization, she embodies its motto: "Be the Change You Want to See."

Additionally, Ms. Berry is a Public Relations Advisor for the North Miami Community Redevelopment Agency. She also plays an important role in a number of community organizations and serves on several boards, among them: the Carrie Meek Foundation, Church World Services, and the Community Affairs Committee of the Museum of Contemporary Art.
