The School Board of Miami-Dade County, Florida, announced on May 11, 2011, its intention to amend School Board Rule 6Gx13- <u>5A-1.10</u>, Attendance Areas 2010-2011, at its meeting of June 15, 2011.

The Attendance Boundary Committee is recommending the following:

- Modify the boundaries of 18 schools for the 2011-2012 school year for Broadmoor and Dr. Henry W. Mack/West Little River elementary schools, Miami Lakes, Palm Springs, North Dade, and Ruben Dario middle schools, Thomas Jefferson Middle School, Earlington Heights, Melrose, Lenora B. Smith, and Santa Clara elementary schools, Dante B. Fascell and Dr. Manuel C. Barreiro elementary schools, Lamar Louise Curry, and Hammocks middle schools, Centennial, Cutler Ridge, and Redland middle schools.
- Establish the boundaries for one new K-8 Academy (Dr. Bowman Foster Ashe/Howard A. Doolin).

The Notice of Intended Action was published in the *Miami Daily Business Review* on May 16, 2011, posted in various places for public information and mailed to various organizations representing persons affected by the amended rule and to individuals requesting notification.

The time to request a hearing or protest the adoption of this rule has elapsed.

In accordance with provisions of the Administrative Procedure Act, this amended rule is presented to The School Board of Miami-Dade County, Florida, for adoption and authorization to file the rule in the official records of The School Board of Miami-Dade County, Florida.

Attached are the Notice of Intended Action and the rule proposed for amendment. Changes from the current rule are indicated by <u>underscoring</u> words to be added and striking through words to be deleted.

NOTICE OF INTENDED ACTION

THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, announced on May 11, 2011, its intention to amend Board Rule 6Gx13- <u>5A-1.10</u>, Attendance Areas 2010-2011, at its meeting of June 15, 2011.

PURPOSE AND EFFECT: To establish attendance zones for elementary and secondary schools for the 2011-2012 school year, which, in effect, relieves overcrowding and better utilizes existing student stations.

SUMMARY: Board approval of this rule would modify previously approved attendance zones and subsequently establishes all Board-approved attendance zones as a Board rule.

Attendance

ATTENDANCE AREAS 2010-2011 2011-2012

The Superintendent of Schools is responsible for proposing attendance areas for the district schools. The Superintendent of Schools will be assisted in this task by District/School Operations, the Office of School Facilities, and the Attendance Boundary Committee.

To comply with the mandate of Class Size Reduction, the Office of School Facilities and District/School Operations will provide the Attendance Boundary Committee and the community with proposed attendance boundary changes for schools in 2010-2011 2011-2012. Community input on these boundary changes will be solicited at Regional Community meetings. Individuals who wish to present alternate recommendations will be assisted by Regional Center staff. Any alternate proposals must be reviewed through the same process as the Superintendent's proposals. Community and Attendance Boundary Committee meetings will be held to present the attendance boundaries established for 2010-2011 2011-2012.

The Attendance Boundary Committee will take the following factors into consideration when reviewing proposed attendance areas regarding school boundaries: compliance with Class Size Reduction Mandate, impact on special education programs, use of available student stations within contiguous areas, degree and extent of transportation, programmatic impact due to lack of student housing, reduction of the number of schools students must attend, integrity of feeder systems, assignment of students from new residential developments to specific schools prior to completion of developments, construction of new schools, promotion and maintenance of diverse school enrollments, and prevention, reduction or elimination of racial isolation to the extent practicable.

Staff in District/School Operations, Office of School Facilities, Information Technology Services, Department of Transportation, Research Services, Office of Diversity Compliance, and Office of Intergovernmental Affairs, Grants Administration and Community Services, will assist the Superintendent of Schools in providing data, analyze proposed attendance areas and prepare recommendations for submission to the Board.
