The purpose of this bid is to purchase, at a firm unit price, quantities, as may be required, of school-bus routes, for the Department of Transportation. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Twenty-two (22) vendors responded to this advertised solicitation.

Inasmuch as prices for Items 22, 24 and 25 are considered excessive, the recommendation reflects that all bids received for these items be rejected. These services will be provided by the Department of Transportation.

This bid is structured to allow the award to each low bidder, per item, who has a sufficient number of buses and drivers required to provide transportation services for the routes identified by the District. Inasmuch as a vendor may have been awarded several routes, which resulted in the utilization of all its resources, the award of additional routes is not possible. Consequently, the award is made to the next low bidder with available resources and equipment. The low bidders for the following items have been awarded the maximum number of routes allowed for their resources, therefore, their low bids could not be awarded for these items:
