Community Partnership for Homeless (CPH) grew out of the grave concern local citizens and elected officials had about the growing problem of homelessness. The late Governor Lawton Chiles appointed a blue-ribbon panel ("Governor's Commission on Homeless") to address this issue. The plan was to bring together the public and private sectors to respond to the growing problem of homelessness within Miami-Dade County. As a result, Community Partnership for Homeless serves as the private sector partner and the Miami-Dade County Homeless Trust is the public partner.

For more than fifteen years, Community Partnership for Homeless has been assisting homeless men, women and children in transitioning off the streets of Miami-Dade County and on their way to attaining greater stability and self-sufficiency in their lives. Many of these families have children who attend the Miami-Dade County Public Schools' system.

CPH's main catalyst for success is the Homeless Assistance Centers which operate as one-stop temporary care entry points that provide not just food and shelter, but comprehensive case management, healthcare, daycare, job training and other assistance from a variety of social service agencies all under one roof.

Currently, Community Partnership for Homeless operates two Homeless Assistance Centers – The Chapman Center in downtown Miami and the South Miami-Dade Center in Homestead. Since opening their doors in 1995, 61.82% of former residents have successfully moved off the streets into a better quality of life.

WHEREAS, for more than fifteen years, Community Partnership for Homeless has been assisting homeless men, women and children, many of whom attend Miami-Dade's public schools, in their transition from the streets to greater stability and self-sufficiency; and

WHEREAS, the success of CPH is due to the Homeless Assistance Centers which provide food, shelter, comprehensive case management, healthcare, daycare, job training and other assistance from a variety of social service agencies at one location; and

WHEREAS, since opening their doors in 1995, CPH has helped more than 60 percent of former residents successfully move off the streets to a better quality of life; and

WHEREAS, executive director, Daniel Vincent, and the staff and supporters of Community Partnership for Homeless are to be commended for their selfless efforts to provide a safe and nurturing environment for the children and families of Miami-Dade County while respecting their human dignity;
