Its most recent and impressive milestone includes the organization's 2011 launch of a model program "Embrace Girl Power! All Girl All Power" in Miami Gardens, which has experienced proven and measurable positive outcomes both socially and academically. In fact, results from the 2011 Florida Comprehensive Achievement Test – 10th Edition indicate that girls enrolled in the Embrace Girl Power! All Girl All Power After-School Academy passed with proficiency levels of 3 and above in reading and mathematics. Students in first and second grades, who were administered the Stanford Achievement Test – 10th Edition all scored 5 or better in the areas of reading and mathematics.

Mrs. Lawrence is to be commended for the passion she demonstrates about the empowerment of young girls and for embracing opportunities that advance their social life and academic excellence.
