Research indicates that students who study the arts are more likely to be elected for class office, participate in math and science fairs and win awards for writing. Children's Art Month was established in 1961 through a collaboration of the National Arts Education Association (NAEA) and the Art & Creative Materials Institute, Inc. (ACMI). In 1969, the observance was renamed Youth Art Month and it was expanded to encompass middle and high school students. Youth Art Month is sponsored by the Council for Art Education, Inc., which encompasses NAEA, the General Federation of Women's Clubs and other groups. It encourages the support of school art programs and emphasizes the value of art education.

Art education has been shown to develop a child's self-esteem and sharpen their critical-thinking skills. It increases multicultural awareness as well as technical, communication and expressive skills.
