The Governor has stated that his pledge of \$1 billion in new state funding for public education is based on a series of town hall meetings and other public input. Although the people of Florida have always passionately supported its public education system, it should be noted that the Governor has listened to them. And while these funds do not eclipse the deep cuts (approximately \$1.3 billion) signed into law by the Governor last year, an increase in funding for schools after so many years of sacrifices is a welcomed possibility.

These funds are vital for our students and teachers and will have a broad positive impact on our school system and our state. Many districts like ours have innovated and found efficiencies during the economic crises, ensuring that new funds would almost entirely go to classroom instruction as well other expenses key to serving our children or would help mitigate other liabilities.

It is important that school districts all across Florida send a strong message that the wave of cuts must end if we are going to continue delivering a quality product for our children. The Governor's budget proposal is a good first step in the right direction.
