Over the years, Miami-Dade County Public Schools has witnessed strong increases in the number of graduates as well as those who plan to attend college. Data has shown that 90% of the students who complete a FAFSA enroll in college. As one of 20 urban school districts from around the country to participate in United States Secretary of Education Arne Duncan's FAFSA Completion Project Pilot, Miami-Dade County Public Schools has organized the 2012 FAFSA Frenzy: Getting Help Paying for College campaign.

FAFSA Frenzy's goal is to prepare all students for postsecondary success and establish a culture of college attendance by utilizing the many partners and resources of Miami-Dade County Public Schools. Miami-Dade County Public Schools currently offers support through College Assistance Program (CAP) advisors and school counselors who collaborate with the Education Fund, College Access Community Partnership, Catalyst Miami, College Summit, and many other groups to work with local, state, and national organizations to provide services and resources for all students.

Completing the FAFSA plays a crucial role in deciding what postsecondary institution to attend. As a result of the 2011 Legislative Session, students are now required to submit a complete, error-free FAFSA to be eligible to receive Florida Bright Futures Scholarships as well as Federal Student Aid. Miami-Dade County Public Schools has determined that it is critical that we launch a community-wide awareness campaign to help students and their families navigate the financial aid and FAFSA completion process.
