His responsibilities included supervising operations of nearly 50 school food service programs, performing on-site location inspections, training and evaluating personnel, as well as serving as liaison to community agencies, education institutions, parent groups, school sites and non-school sites.

Mr. Jackson is active in the community through his work with various organizations including the American Dietetic Association, National School Nutrition Association, and Miami-Dade County Schools Food Association. In 2003, he became the first African American to be elected president of the Florida School Nutrition Association. As president, he represented Governor Jeb Bush on the Governor's Task Force on the Obesity Epidemic. Mr. Jackson's presentation titled "Barriers to Healthy Eating in Schools", which he has presented across the state of Florida, has served as the basis of many nutrition and wellness policies that are required by Florida schools.

In addition, Mr. Jackson served as the first vice president of the Florida Sickle Cell Foundation, past president of the Miami-Dade Sickle Cell Disease Association of America, and past president of the National Association for Sickle Cell Disease of America. He is past president of Sunshine Slopers Ski Club and currently serves on the board of Florida International University Alumni. Mr. Jackson has been recognized with the University of Miami/School of Medicine Man of the Year and Humanitarian of the Year awards as well as the Urban League of Greater Miami-Dade Leadership Miami Award and Greater Miami Chamber of Commerce Leadership Miami Award.
