Since 1995, the South Florida Educational Federal Credit Union has helped hundreds of students fulfill their college dreams and embark on their careers by awarding them the Hubert O. Sibley Four-Year Florida Prepaid Tuition Scholarship.

Each year, 15 winners are awarded a four-year Florida Prepaid College Tuition plan that pays for 120 credit hours at a public university. The education the students receive helps to provide them with tools they can use throughout life.

Named for the Credit Union's former president, the late Hubert O. Sibley, who spent 54 years in service, some 249 scholarships have been awarded.

The Hubert O. Sibley Four-Year Florida Prepaid University Tuition Scholarship applications are available to eligible high school seniors during the first week of March each year. Scholarships are awarded to the winners in May.

More than a dozen Florida universities or colleges are eligible to accept the scholarships, including Miami Dade College, Florida A & M University, Florida International University, Florida State University, University of Central Florida, University of South Florida, and New College of Florida.
