Special Olympics was created in 1968 by Eunice Kennedy Shriver to provide year-round athletic training and competition in Olympic-style sports for children and adults with intellectual disabilities. Special Olympics embraces a healthy lifestyle, developing courage, experiencing joy and sharing gifts, skills and friendship with other athletes and their families. In addition, this international nonprofit organization encourages participants to become productive, empowered members of society. Special Olympics serves over 3.8 million people through more than 200 programs in 180 countries.

Established more than 20 years ago, Special Olympics Miami-Dade County has more than 3,000 participants in 13 different sports ranging from aquatics to golf. Local competition and training take place throughout the year. Those qualifying athletes and teams move on to state competition. Opportunities also exist for athletes compete in national and international events. In preparation, athletes take part in an eight-week training program lead by experienced coaches and caring volunteers.

Athletes aged eight years and older are welcome to participate regardless of their ability level or experience. Also offered are Unified Sports, which join athletes with and without developmental disabilities in training and competition. Athletes and their families participate in Special Olympics Miami-Dade County programs at no charge. The organization is supported through individual and corporate contributions, grants as well as special events.
