More than a half million babies in the United States - that's 1 in every 8 - are born premature each year; worldwide, the number rises to 13 million. The March of Dimes Foundation (MOD) is working to address this crisis, funding lifesaving research and speaking out for legislation that improves care for mothers and babies.

Just this year, more than 7 million people will join their family, friends and colleagues in 900 communities across the nation to march for premature babies. They will march as part of the MOD's annual 'March for Babies' — the longest-running and most widely recognized walking event in the nation — which has generated more than \$2 billion for the March of Dimes over its 42-year history.

The money raised through 'March for Babies' funds important research and programs that help babies begin healthy lives. Those who walk for this cause provide hope and health to more than 500,000 children who are born too soon each year. Participants also help fund programs that aid mothers in having healthy, full-term pregnancies, and help researchers find answers to problems that threaten babies.

The March of Dimes Foundation will be hosting its Miami-Dade 'March for Babies' walk on April 28, 2012 at Tropical Park.
