John Escobar is a father and business owner, and an extraordinary volunteer at David Lawrence Jr. K-8 Center, where his son attends fourth grade. In his native Chile, he sold scrap metal so that he could buy electronics books. In 1999, Mr. Escobar came to the United States and is now the Vice President of Jelectron Inc. of Miami, a company specializing in control and automation solutions for a variety of industries. He is behind a major effort to create a culture of "mini engineers" at the school and is very serious about Science, Technology, Engineering, and Mathematics (STEM) education.

Mr. Escobar has been working on a Green Team extracurricular program for Laurie Futterman's seventh-grade class. Together they created projects to submit to Innovation Generation's L.E.D. Challenge. Last April, Mr. Escobar and David Lawrence Jr. K-8 Center were named winners of iGen's first L.E.D. Student Design Challenge for creating a Classroom Noise Meter in the Best Parental Involvement category.

In the Green Team, Mr. Escobar facilitated the creation and construction of a student built solar-powered waterfall, an earthquake simulation device, and a student built vertical wind turbine that will power a radio transmitter to send messages to parents and visitors to the school. Another energy project currently in the planning stage is converting the school's lawn mower from gas to electric and having a solar-charging station for it.

Currently, in an effort to infuse cutting-edge STEM education into David Lawrence Jr. K-8 Center's curriculum, Mr. Escobar researched and found a company that sells satellite materials so that a collaborative educational team (students from FIU, Alonzo & Tracy Mourning Senior High Biscayne Bay Campus, and David Lawrence Jr. K-8 Center) will work together to build, program, and launch the very first public K-12 satellite. He hopes that this program will call attention to the importance of early STEM education. Mr. Escobar has already procured a contributor to sponsor the project.

On behalf of the School Board, I would like to commend Mr. Escobar for his passion, commitment, and for truly making a difference in the education of students at David Lawrence Jr. K-8 Center.
