The purpose of this contract is to purchase, at firm labor rates, parts, discounts, and/or markups, quantities, as may be required, of automotive repair services and specialized repairs, for School Board vehicles, for the Department of Transportation, Vehicle Maintenance. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Sixteen (16) vendors responded to this advertised solicitation.

Item 3 – Specialized repairs/emergency equipment, lighting/sirens School Police vehicles is not being recommended for award, inasmuch as this item was not quoted. Competitive prices will be solicited for this item, as the need arises, pursuant to School Board Policy 6320 – Purchasing.

Inasmuch as the original award did not reflect a primary and an alternate awardee for Item 7 – Specialized repairs/radiators, furnish all labor, materials, tools, equipment transportation and services, it is recommended that this Board agenda item reflect ABC Radiator & Air, Inc., of North Miami, Florida, as the primary vendor and 3 Star Atlantic Radiator, Inc., of Oakland Park, Florida, as the alternate vendor.
