The Superintendent of Schools requests authorization to enter into a contractual agreement with Victory for Youth Corporation for the Department of Food and Nutrition to provide lunch and snacks to participants of the Victory for Youth Summer Camp Programs.

The above agency sponsors the Summer Food Service Program at various site locations throughout Miami-Dade County. The agency will be billed the amount of \$3.25 per lunch and \$.75 per snack served.

The Department of Food & Nutrition will maintain daily records to bill the agency on a monthly basis for the total number of lunches and snacks served.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent of Schools, to enter into a contractual agreement with Victory for Youth Corporation for the Department of Food and Nutrition to provide lunch and snacks to participants of the Victory Summer Camp Programs from June 11, 2012, through August 3, 2012.
