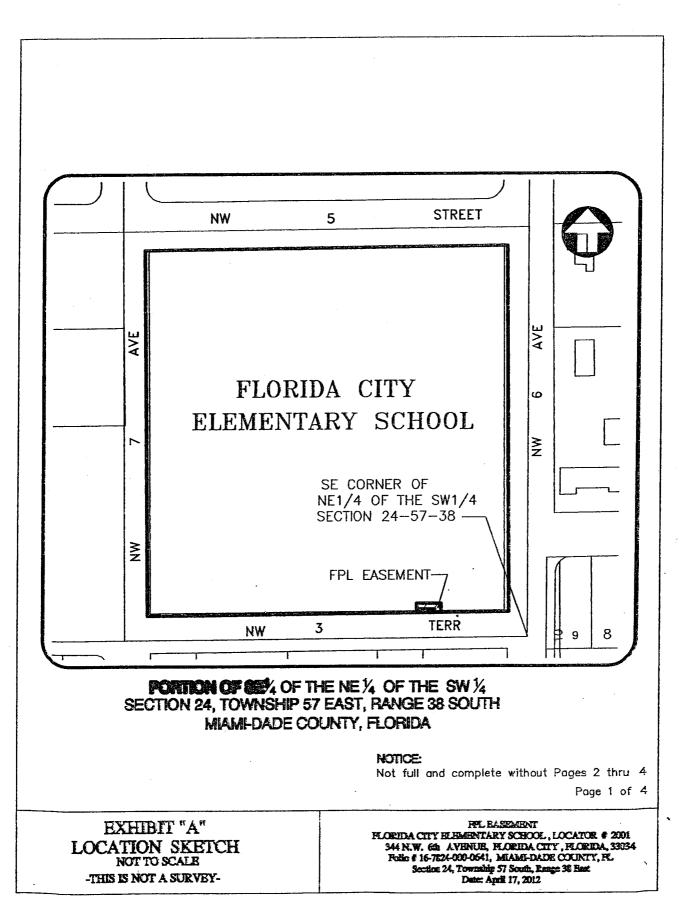

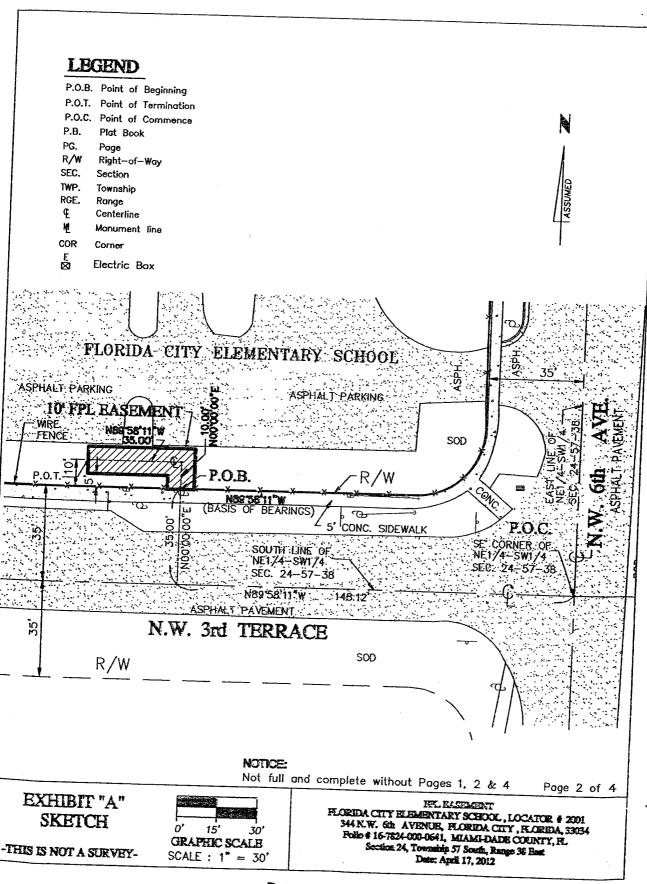
In order to meet the electrical service requirements associated with construction of a classroom addition at Florida City Elementary School (School), located at 344 NW 6 Avenue, Florida City, Florida Power & Light Company has requested that an easement be granted to service the addition. The easement runs along the Southeast portion of the School site, is 10' wide and consists of 450 square feet, or 0.01 acre, more or less. The area is legally described in Exhibit "A", attached hereto.

The Office of School Facilities recommends the granting of the proposed Easement. All documents will be reviewed and approved by the School Board Attorney's Office and Office of Risk and Benefits Management prior to execution.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Chair and Secretary to execute a Grant of Easement Agreement with Florida Power and Light Company for electrical service requirements associated with the construction of a classroom addition at Florida City Elementary School, as described above.

### LEGAL DESCRIPTION OF FPL EASEMENT:

A 10 foot wide utility easement for electrical services purposes lying 5 feet on each side of the following described centerline located in that portion of the SE 1/4 of the NE 1/4 of the SW 1/4, in Section 24, Township 57 South, Range 38 East, lying and being in Miami-Dade County, Florida, more particularly described by metes and bounds as follows:

Commence at the SE corner of the NE 1/4 of the SW 1/4, said Section 24, Township 57 South, Range 38 East, thence N89'58'11"W, along the South line of the NE ¼ of the SW ¼ of said Section 24, a distance of 148.12 feet; thence N00'00'00"E, a distance of 35.00 feet to a point on the North right—of—way of N.W. 3rd Terrace, also being the Point of Beginning of the hereinafter described centerline; thence continue N00'00'00"E, a distance of 10.00 feet; thence N89'58'11"W, along a line 10.00 feet North of and parallel with aforesaid North right—of—way of N.W. 3rd Terrace, a distance of 35.00 feet to the Point of Termination.

The side lines of said easement to be shortened or prolonged to meet the right angle points.
