The Greater Miami Athletic Conference (GMAC) is part of the Division of Athletics and Activities. The goal of the GMAC conference, in cooperation with the Florida High School Athletic Association (FHSAA), is to protect the interest of high schools belonging to the conference and to promote pure amateur sports. The GMAC oversees the scheduling of all high school sports events, implementation and running of the events, and the assignment of officials for all public and private senior high schools in Miami-Dade County.

The GMAC also has 10 subsidiary officials organizations, one of which is the Football Officials Association. The GMAC Football Officials Association has served all Miami-Dade County Public Schools (M-DCPS) that field football teams for more than 75 years and has been named Association of the Year twice by the FHSAA for its leadership, innovation, diversity, and community involvement.

The GMAC Football Officials Association represents a diverse group of men and women who devote countless hours to both officiating and community service. Over the past two years, they have contributed over \$20,000 to charitable organizations and projects including the Jimmy V Blow the Whistle on Cancer project; provided grade appropriate school supplies to every student at Phillis Wheatley Elementary School; contributed time and services to the Fallen Hero project; developed a program to bridge the gap between high schools and their respective feeder pattern schools called Education Champions; and supported the "Galapagos Tools for Schools" program, a two-year effort to provide school supplies to needy children in the Galapagos Islands. Last year, the GMAC Football Association participated in the ING Miami Marathon Kickoff 5K race to raise money for charity.
