Aaron: suspension without pay from her position as School Bus Driver at Southwest Transportation Center, for thirty (30) calendar days, effective October 11, 2012, for just cause, including, but not limited to: violation of School Board Policies 4210, Standards of Ethical Conduct; 4210.01, Code of Ethics; and 8600, Transportation.
