As a part of the partial replacement of Southwest Miami Senior High School, a water line was installed to serve this facility. In order to maintain the water line, Miami-Dade County has requested conveyance of the line, as well as a Grant of Easement Agreement from the District. The 12-foot wide easement will cover the area of the water line installation, as more specifically described in Exhibit "A", attached hereto.

All required documents will be reviewed and approved by the School Board Attorney's Office prior to execution. The Office of School Facilities recommends approval of the documents.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, authorize the Chair and Secretary to execute the documents necessary to convey a water line at Southwest Miami Senior High School, located at 8855 SW 50 Terrace, in favor of and to Miami-Dade County, as well as a Grant of Easement Agreement for same, as described above (Project No. 00363500).


