The financial statements of Miami-Dade Coalition for Community Education (The Coalition), Inc., were audited by Sharpton Brunson & Company, P.A. The Coalition is a not-for-profit corporation organized and operated as a Miami-Dade County School Board's direct-support organization. The audit is required by State Board of Education Rule 6A-1.0013. The auditors concluded that the financial statements present fairly in all material respects the financial position of The Coalition. No audit findings were reported.

Total revenues for The Coalition was \$9,196, which represents a slight increase from the prior year. Total net assets at year-end was \$5,987, which represents a decrease of approximately \$4,000 from the prior year.

The School Board Audit and Budget Advisory Committee reviewed these financial statements at its December 4, 2012, meeting and recommended transmitting them to the School Board.
