Request For Proposals No. 062-NN10 – EXTERNAL INDEPENDENT AUDITING SERVICES FOR WLRN/TV AND RADIO, AND DIRECT SUPPORT ORGANIZATIONS, is to perform audits of the records of The School Board of Miami-Dade County, Florida, relating to three direct-support organizations operated by the School Board: The Miami-Dade Coalition for Community Education, Inc., Magnet Educational Choice Association, Inc., and Dade Schools Athletic Foundation, Inc., and television and radio stations operated by the Board: WLRN - TV and WLRN - FM Radio, for the Office of Management and Compliance Audits. This is a term proposal. Six (6) proposers responded to this advertised solicitation.

The term of the proposal shall be for three (3) years from date of award and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the awardee, be extended for two (2) additional one (1) year periods and, if needed, ninety (90) days beyond the expiration date of the current contract period.

A meeting of the Selection Committee to evaluate the proposals was held on May 13, 2013. Six (6) proposals were presented for consideration: Harvey, Covington & Thomas of South Florida, LLC; James Accounting & Tax Practice, P.A.; S. Davis & Associates, P.A.; Rodriguez, Trueba & Co., C.P.A., P.A.; Sharpton, Brunson & Company, P.A.; and Vizcaino, Gitlin & Zomerfeld, LLP. After considerable discussion, the Committee recommended that Rodriguez, Trueba & Co., C.P.A., P.A., be recommended for award.
